फेस्टिव और वेडिंग सीजन शुरू होने के कारण आगे बिक्री दर बढ़ने की उम्मीद है। नीलसन के एक अधिकारी के अनुसार लॉकडाउन के दौरान स्निकेयर केटेगरी नॉन इसेंशियल लिस्ट में रही। नीविया इन्डिया के प्रबंध निदेशक के अनुसार क्राइसिस के दौरान भारत में हर प्रोडक्ट केटेगरी को अजीब परिस्थितियों का सामना करना पड़ा है। रिटेल स्टोर्स पर लोगों की आवाजाही असामान्य रही। शहरों के लोग बिग साइज में प्रोडक्ट्स खरीदते नजर आये, तो कहीं जॉब लॉस के कारण लोग पैसों की कमी के कारण छोटे पैक खरीदते दिखे। बड़े पैक इसलिये भी ज्यादा खरीद गये ताकि बार-बार शॉपिंग के लिए बाजार न आना पड़े।

## बिक्री बढ़ने के संकेत

लगजरी नहीं जरूरत का उत्पाद बन रहा है। केंट आरओ सिस्टम्स के एक अधिकारी के अनुसार दिल्ली एनसीआर में 70 प्रतिशत बिक्री की जाती है लेकिन अब चालू वर्ष में देश के अन्य शहरों से भी मांग आ रही है। जैसे कि चंडीगढ़, लुधियाना, जालंधर आदि शहरों में भी मांग है। कन्स्यूमर प्रोडक्ट्स एंड रिटेल नेशनल लीडर के अनुसार देश में हवा की क्वालिटी काफी खराब होती जा रही है। इसका असर लोगों के स्वास्थ्य पर पड़ रहा है। दिल्ली, मुम्बई, गुजरात, तमिलनाडू और अन्य मेट्रो शहरों में विशेष रूप से स्थिति काफी खराब बन रही है। एयरओके टेक्नोलॉजीज के फाउंडर के अनुसार इस बार कोविड 19 के कारण एयर प्योरीफायर की बिक्री ज्यादा बढ़ रही है। लोगों संवेदनशील हो रहे हैं और कोई जोखिम नहीं उठाना चाहते।

डोमेस्टिक एयर प्योरीफायर सेगमेंट का आकार वार्षिक स्तर पर करीब दो सौ करोड़ रुपये का है। यूरेका फोर्ब्स, डायसन, केंट, शार्प, पैनासोनिक, फिलिप्स आदि इस केटेगरी की प्रमुख कम्पनियां हैं। टेक्स्की रिसर्च रिपोर्ट ने आकलन किया था कि 2015-2020 के बीच यह केटेगरी 40 प्रतिशत की दर से ग्रो करेगी। लेकिन गत तीन वर्षों में इस श्रेणी में अच्छी ग्रोथ हुई और चालू वर्ष में तो यह पचास प्रतिशत की वृद्धि दर प्राप्त करने की ओर अग्रसर है। इसका एक बड़ा कारण कोविड 19 को आगमन और प्रसार है।

■ बालों को सुखाते समय उन्हें तौलिए से न धिसें, इससे बाल कमजोर हो जाते हैं और आसानी से टूटने या झड़ने लगते हैं। तो इस समस्या से बचने के लिए उन्हें हल्के हाथों से धीरे-धीरे सुखाएं।

■ हेयर स्टाइलिंग प्रोडक्ट का इस्तेमाल कम से कम मात्रा में करें।

■ बालों और जड़ों के लिए तेल बहुत महत्वपूर्ण है। गर्मियों में नारियल तेल और सर्दियों में जैतून या बादाम के तेल से सिर में हल्के हाथों से मालिश करें। बेहतर परिणाम के लिए तेल में थोड़ा सा प्याज का रस मिला लें और फिर उसे बालों में लगाएं, इससे बाल काफी लंबे समय तक अच्छे बने रहते हैं।
